Dear Ms. Salas:

The Southern California Edison Company (SCE) is filing an Application for New License (Application) for the Portal Hydroelectric Power Project, FERC Project No. 2174. The existing License expires March 31, 2003. Enclosed are the original and ten copies of the Application and associated signed affidavit and certificate of service.

This Application, comprised of six volumes, has been prepared in accordance with 18 CFR §§ 4.51 and 16.8. Volume 1 contains the initial statement and Exhibits A, B, C, D, and H; Volume 2 is the Exhibit E Environmental Report; Volume 3 contains the Exhibit E Technical Appendices; Volume 4 is the Confidential Cultural Resources Report; Volume 5 contains Exhibits F and G, which are Confidential Critical Energy Infrastructure Information; and Volume 6 contains Project maps depicting environmental resources and Project facility locations, which are not to be posted on the internet (Non-Internet Public). The privileged information in Volumes 4 and 5 is being filed pursuant to 18 CFR § 388.112 and is exempt from the mandatory disclosure requirements of the Freedom of Information Act (5 U.S.C. §552) and should be withheld from public disclosure. Volume 4 is privileged information because the federal cultural resource laws restrict access to this information and SCE may not share the information with the public. Volume 5 contains drawings that the Commission, in Order No. 630, deemed to be critical energy infrastructure information that must be filed as privileged.

By copy of this letter, SCE is notifying government agencies and other potentially interested parties of the Application (see Distribution List). Agencies and interested parties on the Distribution List will receive the Application documents, except Volume 4 the Cultural Resources Report and Volume 5 Exhibits F and G.
