#### **The CPUC Wants to Hear From Customers About SCE's Response to Recent Power Outages**

The CPUC invites you to attend this very important Public Participating Hearing (PPH) regarding the recent power outages resulting from the wind storms which occurred in November and early December 2011. The severe wind conditions resulted in downed trees and power lines, loss of electric service, road debris, and other safety-related problems in some parts of Southern California Edison (SCE)'s service territory. A CPUC Administrative Law Judge and Commissioners will be present to hear your comments and experiences resulting from SCE's response to the storm. Although a quorum of Commissioners may be present, no official business will be conducted.

SCE will have customer service representatives at the PPH to assist customers with questions and claims related to damages allegedly caused by SCE related to the windstorm power outages. The Commission's Public Advisor will be present to provide information about the CPUC and how to participate in CPUC proceedings. The Consumer Affairs Branch of the Commission will be present to assist customers who want to file an informal complaint on any matter pertaining to the wind storm.
