SUBJECT: Semi-Annual Filing Regarding Service Provider Lists

PURPOSE

As directed by the Affiliate Transaction Rule IV.C.2 of Decision No. 98-08-035 (D.98-08-035), Southern California Edison Company (SCE) hereby submits this semi-annual update describing the development and dissemination of service provider lists to customers who request such information. This is the third of the semi-annual advice letter filings required by Rule IV.C.2 as stated in Appendix B of Decision 98-08-035.

SCE hereby describes its implementation of the procedure ordered by the Commission in Resolution E-3539 for the creation of the "list of all providers of gas-related, electricity-related, or other utility-related goods and services operating in its service territory, including its affiliates," discussed in Rule IV.C.2.

This advice filing replaces Advice 1342-E-A in its entirety.

BACKGROUND

On December 16, 1997, the California Public Utilities Commission (Commission) issued Decision No. 97-12-088 (D.97-12-088) regarding rules which govern transactions between regulated utilities and certain of their affiliates. Appendix A of D.97-12-088 contains Rule IV.C.1 and Rule IV.C.2, which pertain to service provider information. Decision 98-08-035 modified certain provisions of each rule to read as follows:

Rule IV.C.1 states:

“Except upon request by a customer or as otherwise authorized by the Commission, or approved by another governmental body, a utility shall not provide its customers with any list of service providers, which includes or identifies the utility’s affiliates, regardless of whether such list also includes or identifies the names of unaffiliated entities. A utility shall submit lists approved by other governmental bodies in the first semi-annual advice letter filing referenced in Rule IV.C.2 following such approval, but may provide customers with such lists pending action on the advice letter.”

Rule IV.C.2 states:

“If a customer requests information about any affiliated service provider, the utility shall provide a list of all providers of gas-related, electricity-related, or other utility-related goods and services operating in its service territory, including its affiliates. The Commission shall authorize, by semi-annual utility advice letter filing, and either the utility, the Commission, or a Commission-authorized third party provider shall maintain on file with the Commission a copy of the most updated lists of service providers which have been created to disseminate to a customer upon a customer’s request. Any service provider may request that it be included on such list, and, barring Commission direction, the utility shall honor such request. Where maintenance of such list would be unduly burdensome due to the number of service providers, subject to Commission approval by advice letter filing, the utility shall direct the customer to a generally available listing of service providers (e.g., the Yellow Pages). In such cases, no list shall be provided. The list of service providers should make clear that the Commission does not guarantee the financial stability or service quality of the service providers listed by the act of approving this list.”

SCE initially interpreted Rules IV.C.1 and IV.C.2 in its Preliminary and Supplemental Compliance Plans as precluding SCE from distributing only those lists which included affiliates covered by the rules adopted in D.97-12-088.¹ Resolution E-3539 clarified that the Commission’s prohibition on the distribution of lists was intended to include all lists, whether or not they included SCE’s affiliates.

Upon adoption of Resolution E-3539, SCE discontinued distributing its existing lists of service providers as defined by the Commission.² Additionally, SCE

removed or disabled links from SCE's Web sites to sites of other service providers. Since that time, SCE has answered requests for service provider information by directing requesting parties to the Yellow Pages or other generally-available listings of service providers as the Commission has not issued a determination on SCE's initial advice letter regarding lists (Advice 1342-E).³ SCE continues to interpret "generally available lists of service providers" to include, in addition to the Yellow Pages mentioned in the text of the rule, Internet search engines and bulletin boards (e.g., Lycos, Excite, Yahoo, etc.).

SCE filed its first semi-annual advice filing (Advice 1342-E) as required by Rule IV.C.2 on October 16, 1998. The Commission has not issued a determination on that filing or on SCE's subsequent filing on April 16, 1999 (Advice 1342-E-A). This present filing supersedes the prior filings.

DISCUSSION

I. Internet-Based Development of the Service Provider List

Rule IV.C.2 requires SCE to develop, or cause to be developed, a list of "all providers of gas-related, electricity-related, or other utility-related goods and services operating in its service territory." This Rule also directs SCE to include on the Commission-approved list any service provider who requests inclusion. Resolution E-3539 directs SCE to comply with this Rule by posting on its Web site notice of its creation of such list and the process by which interested service providers may be included on the list. In order to comply with these directives, SCE implemented the Internet-based process described below.

To comply with Rule IV.C.2, SCE created a specialized area on its Affiliate Transaction Bulletin Board (www.sceaffiliatebb.com) which is dedicated specifically to the creation and maintenance of the service provider list. By following the link labeled "Service Provider Lists (Rule IV.C.2.)," an interested party can review the Rule itself, submit the necessary information to be included on or removed from the list,⁴ access the currently-approved list, and link to the Commission's list of registered Electric Service Providers.

For those service providers who do not have access to the Internet or who prefer to utilize the mail, SCE has set up the following mailing address: SCE-Service Provider List, Attn: RP&A/Room 410, 2244 Walnut Grove Ave., Rosemead, CA

91770. In accordance with Commission directive, the list will be updated by advice letter on a semi-annual basis, and submitted to the Commission for approval.

Upon Commission approval, the list resulting from this process would be provided to customers in printed form, via e-mail, and on SCE's Affiliate Transactions Web page. Customers may obtain the list in the manner most convenient for them. Although SCE will continue to maintain the process ordered by the Commission, in the twelve months that the process has been in place, service providers have not yet taken advantage of the opportunity. Therefore, SCE will continue to follow the referral procedure described below.

II. Referrals to Generally Available Lists of Service Providers

In compliance with Resolution E-3539, SCE is currently referring customers requesting information about service providers to "generally-available listings of service providers." SCE requests authorization to continue referring customers to these generally-available listings as well as to the list prepared pursuant to the process called for in E-3539 and described above.

Generally-available listings of service providers such as the Yellow Pages or Internet search engines are likely to be more comprehensive than the list created using the aforementioned process, as they are typically produced by firms more focused on actively gathering listing information. Developing a list with such a wide spectrum of gas, electric and utility-related services for dissemination to customers is not a core utility function of SCE. Although Rule IV.C.2 allows the utility, with Commission authorization, to contract with a third party to produce the master list, it is likely to be expensive and would not result in a product which is more extensive and accurate than existing, generally-available listings. Therefore, although SCE has implemented and will maintain the Internet-based process described in Section II above, SCE requests that the Commission approve SCE's continued referral of customers to generally-available listings of service providers if that is the most expeditious and efficient means to respond to a customer's request for information.

III. Focused Lists of Non-Affiliated Service Providers

Neither Rule IV.C.1 nor IV.C.2 directs SCE to provide the comprehensive list of in-territory providers when a customer inquires about service providers other than SCE's affiliates. Rule IV.C.1, however, appears to suggest that the Commission seeks to authorize the lists that may be distributed in response to customer requests about non-affiliated service providers.

Prior to the adoption of Resolution E-3539, SCE had provided customers with lists of manufacturers, distributors or other service providers (or has made links

available on its Web sites) to inform customers of providers with offerings related to energy efficiency, safety, and new or emerging technologies. SCE again requests Commission authorization to resume distribution of the lists, attached to the present filing as Appendices A through J; and further, seeks approval for the Power Quality Web Page (the present Appendix K). These lists will incorporate the appropriate disclaimers described later in this filing, including instructions for service providers who wish to be included on these lists. Table A (below) provides a summary of the focused lists for which SCE is seeking approval.

IV. Government-Approved Lists

After filing the first Service Provider List Advice Letter (1342-E), SCE began to distribute government-approved lists to customers requesting information, and has provided Internet links to government-sponsored or approved Web sites as permitted in Rule IV.C.1. Table B contains the aforementioned government-approved lists (attached to this filing as Appendices M and N) which SCE will continue to provide to customers in accordance with Rule IV.C.1.

2. "Neither the CPUC's approval of this list nor SCE's distribution thereof constitutes any approval, endorsement or guarantee of the financial stability or service quality of the entities included therein. Furthermore, neither the CPUC nor SCE shall be responsible or held liable for the accuracy, completeness or validity of this list."
3. "If you are a business providing gas-related, electricity-related, or other utility-related products and services, and would like to be included on SCE's service provider list, please apply at "www.sceaffiliatebb.com," or write to SCE-Service Provider List, Attn: RP&A/Room 410, 2244 Walnut Grove Ave., Rosemead, CA 91770. If you are a customer of SCE, you do not have to purchase (Affiliate's) products in order to continue to receive quality regulated services from SCE."
