SUBJECT: Semi-Annual Filing Regarding Service Provider Lists
Pursuant to Affiliate Transaction Rule IV.C.2

PURPOSE

As directed by Affiliate Transaction Rule IV.C.2, Southern California Edison Company (SCE) hereby submits for California Public Utilities Commission (Commission) approval this semi-annual update that: 1) describes the development and dissemination of service provider lists to customers who request such information; 2) requests approval of new and/or changed lists for which approval is required; and 3) furnishes the Commission with current lists of non-affiliated energy efficiency-related service providers that SCE currently distributes outside of the approval process due to the continuing need to conserve energy in California following the energy crisis. This is the fifteenth semi-annual advice letter filed in accordance with Rule IV.C.2 as set forth in Appendix B of Decision (D.) 98-08-035. This advice filing supplements and replaces Advice 1904-E in its entirety.

BACKGROUND

Rule IV.C.2 states:

“If a customer requests information about any affiliated service provider, the utility shall provide a list of all providers of gas-related, electricity-related, or other utility-related goods and services operating in its service territory, including its affiliates. The Commission shall authorize, by semi-annual utility advice letter filing, and either the utility, the Commission, or a Commission-authorized third party provider shall maintain on file with the Commission a copy of the most updated lists of service providers which have been created to disseminate to a customer upon a customer’s request. Any service provider may request that it be

included on such list, and, barring Commission direction, the utility shall honor such request. Where maintenance of such list would be unduly burdensome due to the number of service providers, subject to Commission approval by advice letter filing, the utility shall direct the customer to a generally available listing of service providers (e.g., the Yellow Pages). In such cases, no list shall be provided. The list of service providers should make clear that the Commission does not guarantee the financial stability or service quality of the service providers listed by the act of approving this list.”

Advice 1342-E-B, which the Commission approved by letter on February 1, 2000, described SCE’s procedure¹ for the creation of the “list of all providers of gas-related, electricity-related, or other utility-related goods and services operating in its service territory, including its affiliates,” to be provided to a customer requesting information about any affiliated service provider. The Commission also approved SCE’s request in Advice 1342-E-B to continue referring customers to generally available lists of service providers, to resume distribution of focused lists of non-affiliated service providers, and to resume the distribution of government-approved lists. The Commission next approved Advice 1450-E on May 8, 2000, which provided the Commission with updated versions of the lists initially approved in 1342-E-B. Advice 1491-E-I, which supplemented and replaced the previous nine filings with updated versions of various lists, was approved on January 11, 2005. SCE has since filed Advice 1904-E (July 21, 2005), upon which the Commission has not acted. This advice filing supersedes this previous filing in its entirety.

In addition to reiterating the list-creation procedure and SCE’s Commission-approved referrals to generally available lists and sources, this advice letter and its attachments delineate the various list categories and the status of SCE’s request as to each. These categories include:

- Service Provider List Resulting From Internet-Based Process (Approval Requested Herein – Attached as Appendix E)
- Generally Available Lists
- Focused Lists of Non-Affiliated Service Providers

DISCUSSION

I. Internet-Based Development of a Service Provider List

Rule IV.C.2 requires SCE to develop, or cause to be developed, a list of “all providers of gas-related, electricity-related, or other utility-related goods and services operating in its service territory” to be provided if a customer requests information about any affiliated service provider. This Rule also directs SCE to include on the Commission-approved list any service provider who requests inclusion. Commission Resolution E-3539 directed SCE to comply with this Rule by posting on its Web site notice of its creation of such list and the process by which interested service providers may be included on the list.

To comply with Rule IV.C.2, SCE created a specialized area at its Web site: www.sce.com → Regulatory Information Area → SCE Affiliate Notices → Service Provider Lists (Rule IV.C.2), which is dedicated specifically to the creation and maintenance of the service provider list. In addition, for those service providers who do not have access to the internet or who prefer to utilize the mail, SCE has set up the following mailing address: SCE-Service Provider List, Attn: Regulatory Compliance, Quad 4A-G.O.1, 2244 Walnut Grove Ave., Rosemead, CA 91770. In accordance with Commission directive, the list resulting from this process will be updated and submitted to the Commission for approval as part of the semi-annual Rule IV.C Advice Letter.

Upon request for information about an affiliated service provider, the list resulting from this process would be provided to customers in printed form, via e-mail, and/or on SCE’s Affiliate Transactions Web page. Customers may obtain the list in the manner most convenient for them.

Since this process was instituted several years ago, a small number of providers have taken advantage of the self-nomination opportunity. Because this self-nominated list contains only a few service providers, SCE will continue referring customers, on request, to the generally-available lists of service providers, as described in the following section. SCE will continue to maintain the Web-based list creation process, in the event that additional service providers wish to take advantage of the opportunity.

II. Referrals to Generally-Available Lists of Service Providers

SCE will continue referring customers requesting information about service providers to “generally-available listings of service providers” in compliance with Resolution E-3539, which acknowledged that “generally available lists of service providers” includes, in addition to the Yellow Pages mentioned in the text of the Rule, Internet search engines and bulletin boards. This practice was authorized by the Commission in its approval of Advice 1342-E-B in February 2000.

III. Focused Lists of Non-Affiliated Service Providers

Prior to the adoption of Resolution E-3539 in 1998, SCE had routinely provided lists, upon request, of manufacturers, distributors or other service providers (or had made links available on its Web sites) to inform customers of providers with offerings related to energy efficiency, safety, and new or emerging technologies. In approving Advice 1342-E-B and 1450-E, the Commission again authorized SCE to provide such “Focused Lists of Non-Affiliated Service Providers” to its customers upon request.

Table A below identifies the focused lists in this category which the Commission has already approved and which SCE currently distributes upon request.
