In accordance with the "Guidance to all Load-Serving Entities (LSEs) Regarding the Upcoming Monthly Resource Adequacy Requirement Compliance Filings, required by Decision (D.) 05-10-042 in Rulemaking (R.) 04-04-003 dated March 29, 2006," and "Guidance to all Load-Serving Entities (LSEs) Regarding the Upcoming 2007 System and Local Resource Adequacy (RA) Compliance Filings, required by D.06-06-064 and D.06-07-031 in R.05-12-013 and D.05-10-042 in R.04-04-003," Southern California Edison Company (SCE) hereby submits this Supplemental Advice Letter containing corrections to SCE's month-ahead RA Compliance Filings for Compliance Months January 2007 (Advice 2065-E), February 2007 (Advice 2084-E), and March 2007 (Advice 2096-E-B). This submission is in response to a June 14, 2007 e-mail request from Energy Division staff. This submittal includes the entire template for each month on CD-ROM and two hard copies. In each template, all of the changes requested by Energy Division staff are located on Tab 1, "Physical Resources", Column L, the "Bucket 4" resource category, and are highlighted in yellow. Those are the only changes that have been made.
