PURPOSE

The purpose of this advice filing is to supplement Advice 2198-E in order to withdraw the request of Southern California Edison Company ("SCE") for approval of the renewables portfolio standard ("RPS") power purchase agreement ("PPA") between SCE and Daggett Ridge Wind Farm, LLC (the "Daggett Wind Contract").

BACKGROUND

Advice 2198-E was filed on December 31, 2007 to request approval of three RPS PPAs which resulted from SCE's 2007 RPS solicitation: (1) the Daggett Wind Contract; (2) the PPA between SCE and FSE Blythe 1, LLC (the "FSE Contract"); and (3) the PPA between SCE and ORNI #21, LLC (the "ORNI #21 Contract"). On January 11, 2008, SCE supplemented Advice 2198-E by filing Advice 2198-E-A in order to include the Independent Evaluation Report for SCE's 2007 Renewable Resource Solicitation.

The FSE Contract and the ORNI #21 Contract were approved by the California Public Utilities Commission (the "Commission") in Resolutions E-4157 and E-4183, respectively. With respect to the Daggett Wind Contract, SCE requires additional time to prepare and present material relevant to the Commission's consideration of this matter. For this reason, SCE hereby requests that its request made pursuant to Advice 2198-E and 2198-E-A for approval of the Daggett Wind Contract be withdrawn.

TIER DESIGNATION

Pursuant to D.07-01-024, Energy Industry Rule 5.3, SCE submits this advice filing with a Tier 2 designation (effective after Commission approval).

EFFECTIVE DATE

SCE requests that this advice filing become effective by December 8, 2008, subject to review and approval by the Commission.

PROTESTS

SCE asks that the Commission maintain the original protest and comment period as designated in Advice 2198-E, filed on December 31, 2007, because this supplemental advice filing is simply requesting withdrawal of SCE's request for approval of the Daggett Wind Contract.
