Enrolling in SCE's Summer Discount Plan (SDP) for commercial customers can provide your business with as much as \$165\* in savings during the summer season for each of your air conditioning units. Once you sign up and choose a plan option, SCE will install, at no cost to you, a device on your existing central air conditioner(s). Then, during an energy event, we may use the device to cycle your air conditioner off and on, based on the plan option you choose. Your fan will still run though, to allow air to continuously circulate in your place of business. Your savings will appear as a credit on your summer electric bills. Once you sign up, you'll save automatically every summer, year after year. SDP energy events can be called year round, with a maximum of 180 event hours each calendar year. By submitting this application, I confirm that the above information to the best of my knowledge is correct, that I am a Southern California Edison (SCE) customer with a central air conditioner(s) in good working order, and I would like to enroll in the SDP for commercial customers indicated in Section 3.

I understand:

- I will provide SCE or its authorized contractors with reasonable access to my place of business to install, monitor, and maintain the SDP devices,
- My credits are based on my current rate schedule, the amount of my electrical consumption, the calculated tonnage of my working central air conditioner, the number of summer season days in each billing period, and my SDP option,
- SDP devices will not be installed on a non-operational central air conditioner,
- Actual calculated tonnage on air conditioners may be different than the tonnage displayed on the face plate of the unit,
- Program is subject to the availability of devices and adequate signal strength at my location,
- My account must register the use of a minimum of 0.2 kWh per A/C ton, one hour before or after, in at least one event day per calendar year to remain eligible to participate in the SDP Program,
- California Public Utilities Commission (CPUC) has authorized this program, and this agreement will at all times be subject to such changes or modifications by the CPUC as it may direct, from time to time, in the exercise of its jurisdiction,
- SCE can apply to the CPUC at any time to change its rates, charges, rules, or services in any way,
- SCE treats information and research data from individual customers as confidential, and uses statistics and information gathered on a group basis only,
- **SDP for commercial customers requires a minimum of one year participation from the date my service on the plan begins, and**
- **This plan is not recommended for anyone unable to tolerate high temperatures or who has significant health problems such as asthma, heart disease, or respiratory conditions.**

\*The estimated savings amounts represent the savings with a typical 5-ton central air conditioning unit. Savings could increase with larger units and decrease for smaller ones. Maximum credit amounts are subject to certain minimum usage requirements and vary by central air conditioner tonnage. Credits based on enrollment in program from June 1 to October 1. Enrollment after June 1 will result in prorated savings beginning from the next scheduled meter read date after your application is processed and your device is installed and activated. SCE may need to test the device. The credit amounts and program options are subject to change by the California Public Utilities Commission. An Edison SmartConnect® meter or interval data recorder (IDR) meter capable of registering hourly interval usage data is required for enrollment in the SDP program. If removed from the program for failing to meet the minimum electric usage requirement, you will not be allowed to re-enroll for the following 12-month period. This program is not recommended for those with health problems such as asthma, emphysema, heart disease, or other respiratory conditions or those who are unable to tolerate high temperatures. SDP courtesy alerts are provided as an optional notification only, and not a guarantee that an event will impact one or any of your service accounts. Failure to receive an SDP courtesy alert does not exempt program participants from load reduction during an event. Subscribing to, or receiving, SDP courtesy alerts does not replace having a functioning interactive load control or cycling device attached to your air conditioning (HVAC) unit(s) at the location(s) of your service account(s).
