

# TARGETED UNDERGROUNDING

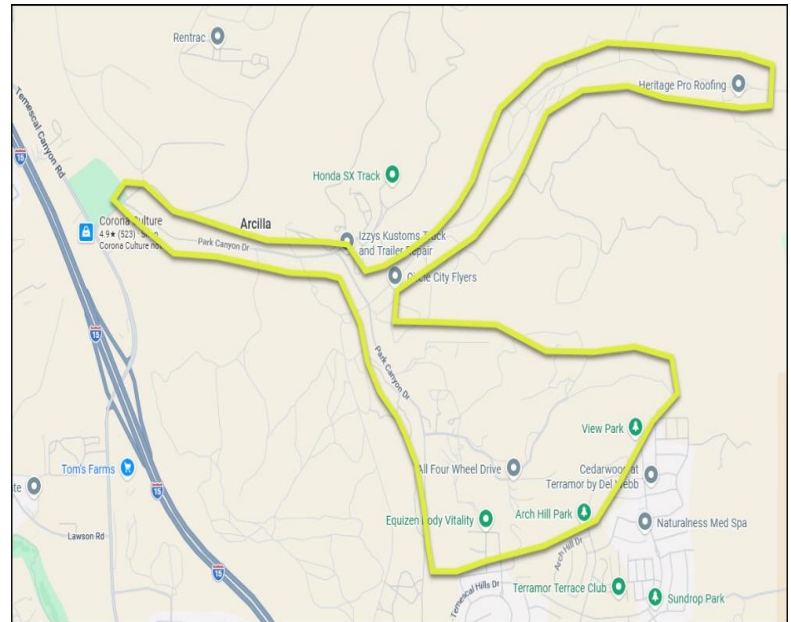
## CONESTOGA CIRCUIT FACT SHEET

### BACKGROUND

As part of ongoing wildfire mitigation efforts, Southern California Edison is undergrounding overhead distribution lines in high fire risk areas to continue to reduce the threat of wildfires, particularly in communities where power lines have not been replaced with covered conductor. Undergrounding electrical systems enhances reliability during high winds and storms by shielding infrastructure from hazardous weather conditions. By placing power lines underground, the risk of outages and ignitions caused by vegetation, debris or metallic balloons coming into contact with overhead lines is virtually eliminated. Additionally, underground systems reduce the likelihood of electrical faults that can lead to wire-down incidents.

### PROJECT AREA

- Underground electrical construction will take place in Temescal Valley, south of the City of Corona. The trench line runs from the north-western intersection of Park Canyon Drive and Dawson Canyon Road heading east and south, continuing onto Spanish Hills Drive to serve the end-of-line residences. The work also branches north-east down Dawson Canyon Road from Circle City Fliers to the end of the roadway. Affected side streets include Sun Way Drive, View Lane, Via Sierra Hermosa, Siesta Lane and Skybird Lane. Work will affect private residences and businesses in this area
- Construction activities may impact the surrounding areas as temporary road closures may be necessary to perform the work safely.



### WORK TIMELINE

- Underground construction is expected to begin in the 3rd Quarter of 2027 with project completion expected in the 2nd Quarter of 2028. Working hours will vary based on permit and traffic control conditions.
- Please be advised these dates and times are subject to change due to unforeseen operational factors or inclement weather.
- Work hours will vary based on permit conditions.

### WHAT CUSTOMERS CAN EXPECT DURING CONSTRUCTION

- SCE contractor crews are responsible for potholing, trenching, vault/manhole/conduit installation and asphalt restoration.
- SCE contractor crews will perform cable installation and remove existing high-voltage overhead electrical lines and associated equipment (e.g., transformers, switches). Keep in mind that there may be noise related to construction work during operating hours.
- To protect your safety during construction, there will be road, traffic lane and sidewalk closures.
- Crews will use appropriate traffic control signs and flags.
- Crews, surveyors and/or inspectors may need to access utility poles and equipment on your property. We will attempt to notify you before visiting your property.
- Crews may need to dig, trim or remove vegetation and trees to safely access electrical equipment. Once work is complete, crew's will restore the area to its original condition
