

2022 Charge Ready Program - Rebate Levels

The below rebate values are applicable for the various programs under the Charge Ready Program for Light Duty electric vehicles. Rebates values are subject to change at any time. Rebate amounts are considered committed at the time of program agreement signature. Rebate issuance is dependent on applicants meeting program eligibility requirements.

All rebates are limited and dependent on remaining funding available in the program. If funding is exhausted, applicants that have not signed a program agreement will not receive a rebate.
