

# Supplier Diversity Frequently Asked Questions

#### What is a diverse supplier?

SCE operates its Supplier Diversity program under the guidelines of the CPUC's General Order 156 (GO 156). Per GO 156, diverse suppliers are defined as at least 51 percent owned by a woman, minority, disabled veteran, lesbian, gay, bisexual and transgender (LGBT) and persons with disabilities business enterprises. Minority classifications include African American, Hispanic American, Native American and Asian American. Owner(s) must be actively engaged in the management and daily operations of the firm and be a U.S. citizen or legal resident.

#### How do I get certified as a diverse supplier?

### What does it mean to be registered with us?

Being registered with SCE means your company has successfully entered its company profile in SCE's Ariba Supplier Information Management (SIM) module. Once you are registered with us, your company's profile is visible for further interaction with us, which MAY include getting on our mailing list to receive communications on upcoming events, contracting opportunities and sourcing activities. Registering doesn't guarantee the right to receive a bid or receive a contract.

#### What happens after I register?

Once you register in our Supplier Registration portal, if we have a need for the good and/or services your company offers, you may be contacted by a member of our procurement team to participate in a more in- depth commercial and technical qualification process. If contacted, please work with our procurement team through this process. Registering doesn't guarantee the right to receive a bid or contract.

#### What documents do I need to complete registration in the supplier registration portal in Ariba?

At a minimum, have the following information on hand:

- Company contact information
- Supplier Profile (Mandatory Questions)
- Highly recommended to provide a short description of what your company does and select any commodities supplied
- Your tax ID number and Dun & Bradstreet number
- Diverse Business Certification(s)

Note: you may be contacted for additional information if selected to go through the supplier qualification process.
