How will I be billed?	<p>Customers will be billed based upon the 50% or 100% for which they have enrolled. The Green Rate premium will be applied to either 50% or 100% of their usage each month. The credits and charges will appear on the customer's energy bill, in addition to the customer's regular electricity charges.</p>
How will my bill be calculated?	<p>The Green Rate premium is estimated to be a credit of 1.1 cents/kWh for a Residential customer. As an example, a customer choosing the 100% option who uses 100 kWh will have the (\$0.01104) cents/kWh applied to 100 kWh for a total Green Rate credit of (\$0.01104). This charge is separate from the otherwise applicable tariff the customer is on. The credit is composed of both charges and credits. Credits for the Green Rate include the Class Average Generation Credit and the Renewable Energy Value Adjustment. Green Rate Charges include the Renewable Power Rate, the GTSR Indifference Adjustment, the CAISO Grid & WREGIS Charges, the RA Adjustment, the Program Administration and Marketing Charge, and the RIC Charge.</p>

Will my rate change over time?	Yes, the rate may change annually based upon the ERRA filing and is subject to CPUC approval.
What sources will be used in my certified product?	See last page for Prospective Product Content Label
Can I move and continue my enrollment in the Green Rate?	Yes, you can move within SCE's territory and still enroll in the Green Rate.
Can I cancel my participation?	Yes, customers may de-enroll at any time, without penalty. However, upon de-enrollment, customers will not be permitted to re-enroll in the program for 12 months.
What is the length of agreement/contract is required?	Customers can sign up on a Month to Month basis. Upon enrollment, the customer will remain on the Green rate unless they ask to be removed.
What other fees might I be charged?	There are no fees or penalties from SCE on the Green Rate program that will be charged.
Can I participate in both the Green Rate and the Community Renewables program at SCE?	No, customers may only be enrolled in one rate at a time.
