## ACTION ITEMS:

1. James Loewen requested that the dimensional pie charts at Slide 14 of the Quarterly Activity Report be replaced with one dimensional pie charts to improve the clarity of the graphic. SCE has agreed to modify its presentation format for the subject slide in future presentations as requested by Mr. Loewen.

- 2. Kevin Woodruff asked for an explanation of the difference between the "Current Inventory" line and "Original Inventory" line of the SO2 transaction summary chart at Slide 15 of the Quarterly Activity Report. The "Original Inventory" line plots SCE's allocated SO2 credits less a minimal amount of SO2 credits that SCE holds back for its on-going generation requirements (i.e., the "Original Inventory" line reflects the amount of SO2 credits that SCE was making available for eventual sale). The "Current Inventory" line is the difference between the "Original Inventory" line and SCE's cumulative sale of SO2 credits through Q3-08. The "Volume from Sales" graphics only reflects the sale of SO2 credits during Q3-08.
- 3. Mary Jo Stueve inquired if SCE submitted comments in the SEC's natural gas investigation. SCE is researching this request and will provide a response shortly.
