## Variable Speed Pool Pump

If your home has an in-ground pool, you may be able to reduce its energy consumption by replacing a single or two-speed pump with a variable speed pool pump. In addition to using a fraction of the energy, variable speed models help your pool run more quietly and extend the life of the filtering system. Receive a rebate by replacing your single-speed pool pump or two-speed pool pump with a qualifying model.

### Requirements

1. Purchase and install a new variable speed pool pump between January 1 and December 31, 2019.
2. Make sure the pool pump appears on the list of qualifying products found at SCE's Marketplace at <https://marketplace.sce.com>.
3. The variable speed pool pump must be installed in a pre-existing or new in-ground pool. A pool pump installed in a spa, Jacuzzi<sup>®</sup> product, or pond does not qualify for a rebate.
4. The pool pump must be installed at a single-family residence.
5. Proof of purchase must be provided with your application if you apply via SCE's Marketplace.
6. Variable speed pool pump must satisfy the ENERGY STAR<sup>®</sup> or California Energy Commission (CEC) standard.
7. Variable speed pool pump must replace existing single or two-speed pool pump. Maximum of one (1) rebate per installation address.
8. Only main filtration pumps are eligible. Booster pumps, which are solely used for added spa jet circulation, or secondary pumps, used for cleaning purposes, are not eligible.
9. Pumps being replaced must be disposed of, and not refurbished and sold.
10. Visit SCE's Marketplace at <https://marketplace.sce.com> to view list of retailers or dealers offering an instant rebate. If you received a Point of Sale discount with a Participating Retailer or Distributor, you are not eligible to submit your application via Marketplace to receive a rebate.

All pool equipment and materials must be new. Please follow manufacturer installation requirements. Equipment/materials must meet or exceed all applicable local, state, and federal standards, as well as all the noted requirements for each product installed. An on-site inspection or verification of the product(s) purchased and installed may be required before the rebate is paid. The following product types are **not** eligible: rebuilt, refurbished, or reconditioned products, rented or leased products, products won as prizes, or new parts installed in existing units.

## Rebates — How to Apply Online or SCE's Marketplace

**Step 1** **Read** the Terms and Conditions on the last page.

**Step 2** **Purchase** qualifying product(s) within the date ranges specified in the requirements of each rebate information section.

**Step 3** **Install** qualifying product(s) within the date ranges specified in the requirements of each rebate information section.

**Two ways to receive your rebate.** Apply by completing and submitting your information on SCE's Marketplace. Or, contact one of the Authorized Retailers or Dealers to obtain an instant rebate on your purchase of a Qualified Product.

Apply online by visiting SCE's Marketplace at <https://marketplace.sce.com> and click on the "Authorized Retailer & Dealers" link to see a list of Retailer & Dealers that offer a Point of Sale discount. Or, purchase online and come back to Marketplace to submit your application to obtain a rebate. If you received a Point of Sale discount with a Participating Retailer or Distributor, you are not eligible to submit your application via Marketplace to receive a rebate.

### Important Information

Rebates are available for existing single-family homes, attached multi-family homes (up to four-plex), condominiums, and mobile homes. **New construction homes do not qualify.**

**Rebates for this program are for a limited-time only and may be terminated without prior notice.** If all program requirements are met, a rebate will be paid in generally 3-8 weeks. If your application is selected for inspection, processing may take additional time.

**Keep a copy** of your completed application with required documentation (including receipts or home improvement contract) for your records.

Program terms and conditions apply. The program is funded by California investor-owned utility customers and administered by Southern California Edison under the auspices of the California Public Utilities Commission. California customers are not obligated to purchase any full-fee service or other services not funded by this program. The program is subject to termination or change without prior notice.

## Home Energy Efficiency Rebate Program

By submitting the 2019 Home Energy Efficiency Rebate (HEER) Program Application, I understand and agree to the following:

1. To be eligible for the rebate, all product(s) must be (i) newly purchased, (ii) installed in a fully constructed dwelling in SCE's service area with an active SCE service account at the time of installation ("Installation Address"), and (iii) designed to reduce consumption of energy distributed by SCE to the Installation Address. Additionally, products must meet the requirements specific to each type of product rebate listed in "Information on Rebates and Requirements" contained in this Rebate Application Package. All uses herein of the words "install", "installation", or similar phrases shall mean complete installation such that the subject products are fully functional.
2. Qualifying product(s) must be purchased and installed between January 1 and December 31, 2019. The application and all other required documentation, including all appropriate Proof(s) of Purchase, must be submitted via SCE's Marketplace, and submitted no later than January 31, 2020.
3. Funds are limited. Applications are accepted on a first-come, first-served basis. The HEER Program may be modified or terminated without prior notice. In the event that rebate terms change, the order/purchase date will be used to determine product eligibility and the application received date (or the date the completed online application was received) will be determined.
4. A complete application must be submitted for each installation via SCE's Marketplace only if the applicant purchased the product online and DID NOT obtain the instant rebate from an Authorized Retailer or Dealer. Products can not be installed at a P.O. Box address.
5. If submitting application(s) online, the application will not be complete until all required supporting documentation, including all appropriate Proof(s) of Purchase are delivered to SCE. Supporting documentation must be received within 30 days of submitting the online application. Only the Customer of Record may submit an application online. If the application is submitted by the landlord or property manager to the Installation Address or by the resident of a sub-metered mobile home, the application must be submitted online. If submitting the application(s) online, the application and all required documentation, including proof of purchase (receipt), must be eligible.
6. Rebates may be gift cards, electronic cash payments, or rebate checks. SCE will no longer honor Bill Credits. The rebate payment will be issued to the Customer of Record at the Installation Address, unless the application provides an alternative payee and payment information. Rebate payment will be issued 3-8 weeks after SCE determines an application is complete and all requirements have been met, provided there are sufficient rebate funds remaining.
7. SCE reserves the right to select any application for inspection/verification and to reject any incomplete applications. If an application is selected for inspection/verification, additional time may be required before a rebate payment is issued.
8. If requested, I will allow (or, if I am not a current occupant at the Installation Address, I will arrange for the current occupant to allow) SCE and/or the California Public Utilities Commission (CPUC) representative(s) reasonable access to the Installation Address to verify installation of the qualifying product purchased, either before or after payment of a rebate. I understand a rebate will not be paid if the occupant at the Installation Address refuses to participate in any required inspection/verification. I understand if I (and/or the occupant of the Installation Address) refuse to participate in or fail any required inspection/verification after receiving a rebate, I may be required to repay to SCE the amount of any rebate received.  

The inspection/verification of installation must be scheduled within 30 days of customer contact by SCE. I understand SCE may contact the qualifying product vendor and/or installer to verify purchase and/or installation and may provide my name and/or address to complete this inspection/verification.
9. I have installed a qualifying product(s) and understand the energy-efficiency level of the qualifying product(s) determines the rebate amount. The rebate amount may not exceed the purchase price. I understand I cannot receive a rebate for the same product from more than one California investor-owned utility or third-party energy efficiency program offering rebates, financing, or other incentives funded with CPUC Public Goods Charge funds.
10. I agree the selection of qualifying product(s), selection of manufacturer, dealer, supplier and/or installer, and purchase, installation and ownership/maintenance of the qualifying product(s) referenced in this Application are my sole responsibility, and the manufacturer, dealer, supplier, or installer of these products is not an agent or representative of SCE.
11. I understand SCE makes no representations regarding manufacturers, dealers, contractors, materials, or workmanship. I also understand SCE makes no warranty whether express or implied, including without limitation, the implied warranties of merchantability and fitness for any particular purpose, use, or application of the products.
12. I agree SCE has no liability whatsoever concerning (1) the quality, safety and/or installation of the products, including their fitness for any purpose, (2) the estimated energy savings of the products, (3) the workmanship of any third parties, (4) the installation or use of the products including, but not limited to, effects on indoor pollutants, or (5) any other matter with respect to the 2019 HEER Program. I waive any and all claims against SCE, its parent companies, directors, officers, employees, or agents arising out of activities conducted by or on behalf of SCE in connection with my Application for any rebate(s) under the 2019 HEER Program. Without limiting the generality of the foregoing, none of such parties shall be liable hereunder for any type of damages, whether direct, or indirect, incidental, consequential, exemplary, reliance, punitive, or special damages, including damages for loss of use, regardless of the form of action, whether in contract, indemnity, warranty, strict liability, or tort, including negligence of any kind.
13. I am responsible for meeting all 2019 HEER Program requirements and complying with my state/county/city government's, and/or property owner and/or homeowners association requirements (if any) in my area regarding permits, local conditions, restrictions, codes, ordinances, rules, and regulations concerning this installation.
14. If a tenant, I am responsible for obtaining the property owner's permission to install the product(s) for which I am applying for a rebate. My signature on this Application indicates I have obtained this "permission."
15. SCE is not responsible for items lost or destroyed in electronic transmission, the mail, or other transit.
16. SCE utilizes the "Point-of-Sale" method of program delivery for selected products with participating retailers and/or dealers. Under this method, customers will receive applicable rebates instantly at the cash register. Such purchases are not eligible for a second rebate through the online SCE Marketplace.
17. All responses are kept confidential. However, SCE may disclose information from my response to the CPUC as required by the CPUC.
18. I certify the information in my rebate application is true and complete, and the product(s) and/or equipment for which I am requesting a rebate have been installed and meet(s) the requirements in this application. I further certify the installation has complied with any applicable permitting requirements and, if a contractor performed the installation, the contractor holds the appropriate license for the work performed.
