Proposed Site Closure Former Edison San Bernardino Generating Station Redlands, California

PUBLIC COMMENT PERIOD: June 15, 2012 through July 31, 2012

What is being proposed? - The Department of Toxic Substances Control (DTSC) invites you to review and comment on the proposed Remedy Complete/No Further Action determination for the Former Southern California Edison (Edison) San Bernardino Generating Station that is located at 2492 West San Bernardino Avenue, in the city of Redlands, San Bernardino County. DTSC regulates the generation, storage, treatment and disposal of hazardous waste in California. The proposed Remedy Complete/No further Action determination by DTSC indicates that Edison has conducted all appropriate environmental investigations and remedial actions required to demonstrate that the site is considered acceptable for unrestricted use. The facility is located in a developed area zoned for industrial land use.

CALIFORNIA ENVIRONMENTAL QUALITY ACT – NOTICE OF EXEMPTION – DTSC evaluated any possible environmental impacts associated with the proposed Remedy Complete/No Further Action determination for this facility, as required by the California Environmental Quality Act (CEQA). DTSC has prepared a Notice of Exemption (NOE) which states that the proposed determination would not result in adverse impacts to human health and the environment. The findings are available for public review in the information repositories listed below. A 45-day public comment period has been established, from June 15, 2012 to July 31, 2012.
