# SOUTHERN CALIFORNIA EDISON COMPANY'S REQUEST TO INCREASE RATES FOR ELECTRIC VEHICLE CHARGING AT SCHOOLS, STATE PARKS, AND BEACHES

## A.18-07-022

## **Summary**

On July 30, 2018, Southern California Edison Company (SCE) filed Application (A.) 18-07-022 with the California Public Utilities Commission (CPUC) requesting approval to increase rates for electric vehicle charging stations. This request will include the implementation of two, 2-year pilots to provide electric vehicle charging at schools, state parks and beaches in SCE's service area. This application follows guidelines set forth in Assembly Bill (AB) 1082 and AB 1083. SCE is seeking to recover a total of \$19.8 million for costs associated with the pilots, beginning January 2019.

If approved, SCE's AB 1082 pilot will provide infrastructure to support approximately 250 charge ports at approximately 40 K-12 schools in SCE's service area. SCE's AB 1083 pilot would provide infrastructure to support approximately 130 ports and 15 portable charging devices at approximately 27 state parks or beach locations in SCE's service area.

Both pilots would be implemented together with a new marketing, education and outreach plan. The AB 1082 pilot would focus on students, faculty, and staff. The AB 1083 would focus on visitors and employees of state parks and beaches. Both pilots focus on the continued deployment of electric vehicle infrastructure programs to support and accelerate electric vehicle adoption. These efforts are consistent with California's efforts to reduce greenhouse gas (GHG) emissions by 2030.

# RATE IMPACT OF SCE'S APPLICATION

If the CPUC approves SCE's application as proposed, an average non-CARE residential customer using 550 kWh per month could see a monthly bill increase of \$0.03, from a current monthly bill of \$111.26 to \$111.29. The following table compares SCE's current bundled average rates, by customer group, to proposed bundled average rates in 2018 if SCE's application is approved by the CPUC:

## **CPUC Process**

The application will be assigned to one or more Administrative Law Judges (Judges) who will determine how to receive evidence and other related documents necessary for the CPUC to establish a record upon which to base its decision. Evidentiary Hearings (EHs) may be held where parties of record will present their testimony and may be subject to cross-examination by other parties. These EHs are open to the public, but only those who are parties of record can participate.

After considering all proposals and evidence presented during the formal hearing process, Judges will issue a proposed decision which may adopt SCE's application as proposed, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision. The proposed decision, and any alternate decisions, will be discussed and voted upon at a scheduled CPUC Voting Meeting.

The Office of Ratepayer Advocates (ORA) may review this application on behalf of SCE's ratepayers. ORA is the independent consumer advocate within the CPUC with a legislative mandate to represent investor-owned utility customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. ORA has a multi-disciplinary staff with expertise in economics, finance, accounting, and engineering.
