ABOUT SCE'S APPLICATION

On April 22, 2019, SCE filed its application seeking authority to establish its authorized cost of capital adjustment for utility operations for 2020. The authorized cost of capital determines how much money SCE is allowed to collect in rates as a return on the money it has invested.

In this proceeding, SCE requests that the CPUC determine a reasonable capital structure (financial plan), the costs of long-term debt (loans and financial obligations over one year), and an appropriate rate of return on common equity (profit for SCE shareholders). SCE's proposal is summarized below:

The proposed changes to the cost of capital would increase SCE's current authorized revenue by \$204 million (8.28%). If the CPUC approves SCE's request, SCE's customers' rates will increase beginning January 1, 2020 until the next cost of capital application is filed in early 2022.

THE KEY REASONS FOR SCE'S PROPOSED INCREASE

If the CPUC approves this application, the cost of capital proposed in this application will:

- 1. Fairly compensate SCE shareholders and permit SCE to attract capital to meet its obligations to serve its customers safely and reliably
- 2. Allow SCE to mitigate financial risks to SCE, including risks related to California's wildfires

WHAT THIS PROPOSED APPLICATION MEANS TO YOU

The table below shows an estimate of proposed revenues and rate changes by customer group. The proposed revenue requirement increase is 2.2 percent. Any revenue change resulting from this application will reflect the actual outcome in the cost of capital case and other revenue changes from other SCE applications.

Based on rates currently in effect at the time the application was filed, the bill for a typical residential NonCARE customer using 500 kWh per month would increase from \$91.30 to \$93.75 or 2.7%. Actual bill impacts will vary depending on usage.
