## It isn't summer without a break.

Give your energy bill a break this summer. Simply sign up for our Summer Discount Plan (SDP) and enjoy the monthly credits on your summer energy bills — June 1 to October 1.

Once you enroll, we'll install, at absolutely no charge, a remote-controlled device to automatically cycle off your A/C's compressor temporarily when an energy event is called. These events can be called year-round when the demand for electricity is high, the costs for energy spike, or as part of a test. The cycling event is temporary and, your A/C's fan will continue to run and circulate air, making the shift in temperature hardly noticeable by your customers or employees.



## Courtesy Alerts



For your convenience, we offer courtesy alerts to let you know when an energy event is occurring in your area and when your A/C compressor(s) are being temporarily cycled off.



You can choose to be notified by email, voice message, or text message.

## Choose from three cycling options.

Customize your reward by selecting one of the three cycling options that best fits your operational needs and desired comfort level. Give your earning potential a boost by enrolling more than one A/C unit. You can earn up to \$225\* for each unit.

### Maximum Savings 100% Cycling | \$225\*

### Good Value 50% Cycling | \$80\*

A/C compressor shuts off 50% of the time, or 15 minutes out of every 30 minutes

A/C compressor shuts off 30% of the time, or 9 minutes out of every 30 minutes

## Here are some important facts.

- Your participation in SDP requires a one-year commitment from the first meter-read date following activation of your cycling device(s). Your participation will continue until you notify us you no longer want to participate.
- This program is not recommended for individuals with health problems, such as asthma, emphysema, heart disease, respiratory conditions, or an inability to tolerate high temperatures.
- The cycling devices can only be installed on central A/C units in good working order; be sure to check yours before enrolling in the program.
- Some central A/C units are not compatible with the cycling device; these A/C units are not eligible for the program.
- Your account must register the use of a minimum of 0.2 kWh per A/C ton, one hour before or after, in at least one event day per calendar year to remain eligible to participate in the SDP program.

\* The estimated savings assume a typical 5-ton central air conditioning unit, enrolled in the program from June 1 to October 1. Savings could increase with larger units and decrease for smaller ones. Maximum credit amounts are subject to certain minimum usage requirements and vary by central air conditioner tonnage. Enrollment after June 1 will result in prorated savings beginning from the next scheduled meter read date after your application is processed and your device is installed and activated. SCE may need to test or replace the device. The credit amounts and program options are subject to change by the California Public Utilities Commission. An Edison SmartConnect® meter or interval data recorder (IDR) meter capable of registering hourly interval usage data is required for enrollment in the SDP program. If removed from the program for failing to meet the minimum electric usage requirement, you will not be allowed to re-enroll for the following 12-month period. Participation in Critical Peak Pricing may also reduce the maximum credit amounts. This program is not recommended for those with health problems, respiratory conditions, or an inability to tolerate high temperatures.
