Supplier Registration FAQs

Frequently Asked Questions

Questions are updated from time to time, so please check back regularly.

1. How do I register with SCE in Ariba?

Use the URL below to register in Ariba:

Or, you can visit the SCE Supply Management web page at <u>www.SCE.com</u> and navigate to: Partners & Vendors > Buying and Selling > Overview – Buying and Selling > Register Your Company to Do Business with SCE.

2. What does registration entail?

There are two parts to the registration process. First, create your account in Ariba and provide some general information about your company. You will receive a registration confirmation email from Ariba. Second, you will then log in to Ariba and complete the SCE Profile Questionnaire.

3. Is there a fee to register in the Ariba system?

No, there is no fee to register. However, there may be fees related to transacting orders and processing invoices through the system. The fee structure for services provided through Ariba is available for review on the Ariba web site.

4. I've already registered in your Supplier Registration portal at sce.cvmsolutions.com. Do I need to register again in the SCE Ariba system?

Yes, you will need to register in Ariba. Ariba is where you store and maintain your company information for working with SCE. SCE also notifies suppliers of sourcing events, contracting, and more through this system.

5. If I've already registered in your Supplier Registration portal at sce.cvmsolutions.com, will my company information automatically transfer over to the Ariba system?

It will not automatically transfer. Re-entering your information into the Ariba system is the best way to ensure we have your current information. In addition, the Ariba system allows you to update your information as circumstances change. The system will prompt you periodically to review and confirm the information on file.

6. What will happen to my company information that was entered in the previous Supplier Registration portal at sce.cvmsolutions.com?

Your information will be handled in compliance with the CVM terms of use.

7. What information and documents do I need to complete my registration in the SCE Ariba system?

Before you start the registration process, please have the following items on hand:

- Company contact information and a brief summary of your company's capabilities.
- Your tax ID number and Dun & Bradstreet number.
- Certificates (Diverse Business Enterprise [WMDVBE], insurance, business licenses, etc.).
- EMR (Experience Modification Rate) if work may be performed on an SCE job site or at an SCE facility.

8. Once I complete my company's registration in the SCE Ariba system, will I receive a notice of what to expect next?

You will be notified that the registration submission has been received. Following review of your information, we will notify you that your registration is complete. At that time, your company information will be visible to SCE Procurement Agents and discoverable for future interaction.

9. Who will have access to my company information?

Any SCE Procurement Agent or other authorized SCE personnel will have access to the information.

10. Once I complete my company's registration in the SCE Ariba system, will I automatically begin receiving RFPs?

No. Registering in Ariba does not guarantee that you will receive an invitation to bid on SCE projects. Selection of suppliers invited to a Sourcing event is dependent on the category of materials or services needed, timing, and other factors.

11. Once I complete my company's registration in the SCE Ariba system, will I have access to view all upcoming SCE Sourcing opportunities?

Typically, SCE's Procurement Agents choose to publish a Sourcing event to a group of suppliers that meet the qualification criteria established for the event, and only those suppliers are able to access the Sourcing opportunity.

Please note that after the Sourcing opportunity has closed, access to additional information about the Sourcing opportunity may be limited to those who have responded to the initial solicitation.

12. What is a "Diverse Business Enterprise (DBE)"?

A Diverse Business Enterprise (also known as WMDVBE) is a business:

- That is at least 51 percent woman-, minority-, disabled veteran-, or lesbian, gay, bisexual, or transgender (LGBT)-owned by an individual or group; or
- In the case of a publicly owned business, at least 51 percent of the stock of which is owned by one or more women, minorities, disabled veteran, or LGBT individuals; and
- Whose management and daily business operations are controlled by one or more of those individuals.
- The person(s) owning such an enterprise must be either U.S. citizens or legal aliens with permanent residence status in the United States.

13. Does my company have to be certified as a WMDVBE?

No, it is not required to be certified as a WMDVBE to do business with SCE, however, SCE strongly encourages companies who qualify for WMDVBE status to get certified through one of the agencies SCE recognizes under GO 156. Only transactions with certified WMDVBEs qualify towards SCE's diversity spend goals.

14. What types of WMDVBE certifications are accepted by SCE?

SCE accepts WMDVBE certifications from the following agencies:

- The Supplier Clearinghouse for minority- or women-owned business certification.

- Department of General Services (California Procurement Division) for disabled veteran-owned business certification.

15. How long will my company information be held in the Ariba system?

Ariba will hold your company data as long as you are registered with Ariba, or we have contracts with you that we need to administer through the Ariba system.

16. How often do I need to update my company information?

You should update it whenever necessary to keep your information current. Some documents (e.g., WMDVBE certificate, certificates of insurance, financial settlements, licenses, etc.) may need to be updated annually, along with confirmation that the information is correct if no changes need to be made. You will receive a reminder a few months before the expiration of the document and be prompted to verify information or to provide the required certifications from time to time.

17. How is my confidential and proprietary information protected?

Ariba protects supplier and company information using:

- Multiple-level firewalls to segregate and secure network segments based on system roles.
- Data transmissions encrypted using SSL technology.
- Security auditing performed by outside consulting agencies.
