**Executive Summary**

On July 9, 2019, Southern California Edison (SCE) activated its Emergency Operations Center to perform response operations associated with an elevated weather event with the potential for employment of SCE's Public Safety Power Shutoff (PSPS) protocol. Approximately 3,910 customers were initially identified in portions of Kern and Riverside counties as potentially impacted. Pro-active de-energization was ultimately not required. However, appropriate notifications of the potential event were made to public safety partners, critical infrastructure providers and customers pursuant to Resolution ESRB-8 and Decision (D.) 19-05-042.

SCE submits the following report to the California Public Utilities Commission's (CPUC) Director of the Safety and Enforcement Division pursuant to Resolution ESRB-8 and Decision (D.) 19-05-042. In separate sections of this report, SCE sets forth the reasons for its decision to notify customers of the potential for de-energization, including the day-by-day background for the event, and responds to the questions as required in ESRB-8 and D.19-05-042.

### **SCE's Decision to Notify Customers**

SCE's decision to notify customers of potential use of the Public Safety Power Shutoff (PSPS) protocol was based on the following factors:

- Individual wind thresholds for circuits based on High Fire Risk Area (HFRA) maps and a combination of actual and historical wind data signified a heightened risk of potential impacts from an incoming weather event;
- The assigned rating of the SCE Fire Potential Index (FPI) was “elevated” or higher for circuits identified in the High Fire Risk Area;<sup>1</sup> and
- Actions taken to manage the response included:
  - Operating restrictions on impacted circuits in Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, and Tulare Counties;<sup>2</sup>
  - Activation of an Incident Management Team for response operations associated with potential de-energization;
  - Notifications to public safety partners, critical infrastructure providers and customers;
  - Patrolling of impacted circuits before the event; and
  - Monitoring impacted circuits during the event for the need to execute the Public Safety Power Shutoff Protocol to maintain public safety.

Additional details of the event leading to the decision to send notifications can also be found in the associated report timeline.

<sup>1</sup>The SCE Fire Potential Index is an internal tool that utilizes both modeled forecasted meteorological conditions and conditions of fuels to give context to potential impacts due to weather. Inputs to the FPI include wind conditions, dryness of the air near the ground, and moisture content of the vegetation. The FPI is comprised of three ratings; moderate, elevated and extreme with specific response actions associated with each rating.

<sup>2</sup> Specific operating restrictions SCE may employ during a Public Safety Power Shutoff can be found in the 2019 SCE Wildfire Mitigation Plan approved by the CPUC on May 30, 2019.

**Event Timeline July 9 to July 21, 2019**

*Tuesday, July 9*, SCE meteorologists notified SCE personnel of forecasts predicting local winds with high gusts, hot temperatures, and very dry conditions creating an elevated fire weather threat as determined by the SCE FPI beginning Friday, July 12, through Saturday, July 13. Per SCE's established protocols, the Business Resiliency Duty Manager began daily situational awareness coordination calls to review potential weather conditions and monitor the need for activation of a PSPS Incident Management Team.

Based on forecasted weather from the SCE meteorologists and input from internal subject matter experts participating in the coordination call, SCE continued operating restrictions in Kern, Los Angeles, Riverside and San Bernardino counties through Saturday, July 13, and initiated operating restrictions in Tulare County through Sunday, July 14. Circuits on the monitoring list included the Erskine Circuit in Kern County and the Fingal Circuit in Riverside County, which were expected to meet PSPS criteria between July 12 and July 13.

To manage this incident, PSPS Incident Management Team (IMT) 2 was activated at the SCE Emergency Operations Center (EOC) effective July 9 at 1:00 p.m. to begin execution of the PSPS protocol. Actions included providing notification to emergency and public safety partners and critical infrastructure providers. At 3:30 p.m., SCE notified the California Office of Emergency Services (Cal OES) of SCE's potential implementation of PSPS protocol that could potentially impact 3,910 customers in Riverside and Kern Counties.

*Wednesday, July 10*, based on updated forecasting analysis, SCE meteorologists added the Cuddeback Circuit in Kern County, Birchim Circuit in Inyo and Mono counties, and the Bootlegger Circuit in Los Angeles County. The Fingal Circuit in Riverside County was removed due to improved conditions. Review of updated forecasting analysis resulted in the removal of the Bootlegger Circuit based on improved conditions and addition of the Hession Circuit in Inyo County, which was expected to meet PSPS criteria on July 14. Operating restrictions remained in place for portions of Kern, Los Angeles, Riverside, San Bernardino, and Tulare counties through July 14.

SCE began notifying local governments and impacted customers of the potential for proactive de-energization for the period of concern of July 12 through July 14. Customer notifications were made to 3,082 customers (including 38 critical care customers) on the Erskine Circuit in Kern County which was forecasted to meet PSPS criteria on July 12. In accordance with SCE internal notification protocols, customer notifications were not distributed for circuits expected to meet PSPS criteria beyond the 48-hour timeframe.

SCE sent a field service representative (FSR) to one critical customer's residence after the customer notification was identified as undeliverable. No one answered at the residence, and the FSR left a notice on the resident's front door. Positive contact was later made with the critical care customer.

*Thursday, July 11*, based on updated forecasting analysis and improved conditions, SCE meteorologists removed the Cuddeback, Hession and Birchim Circuits. Additionally, the Faye and Tungsten Circuits in Kern County, Shovel and Bootlegger Circuits in Los Angeles County, and Fingal Circuit in Riverside County were added to the circuit monitoring list and expected to meet PSPS criteria between July 13 and July 15. Updated forecasting analysis in the afternoon resulted in the removal of the Shovel Circuit and the addition of four circuits expected to meet PSPS criteria between July 14 and July 15: Birchim Circuit in Inyo and Mono counties, and the Bonanza, Canebrake and Horse Mountain Circuits in Kern County.

Operating restrictions were initiated for portions of Inyo, Mono, and Santa Barbara counties and remained in place for portions of Kern, Los Angeles, Riverside, San Bernardino, and Tulare counties, through July 16. SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers according to internal notification protocols.

*Friday, July 12*, based on updated forecasting analysis, SCE meteorologists removed the Bonanza Circuit and added five circuits to the monitoring list: Kona Circuit in Kern County, Tejon Circuit in Kern and Los Angeles counties, Shovel Circuit in Los Angeles County, Devers-Venwind Circuit in Riverside County and the Campanula Circuit in San Bernardino County, bringing the number of of potentially impacted customers to 13,124. SCE expert review of aerial surveys later resulted in the removal of the Kona Circuit in Riverside County from the monitoring list.

Based on updated forecasting analysis and improved conditions, the Campanula, Tejon, and Devers-Venwind Circuits were removed from the circuit monitoring list as they no longer met PSPS criteria. SCE meteorologists added the Hession and Underwood Circuits in Inyo County, Bonanza, Mustang, Borel-Isabella and Tungsten Circuits in Kern County and Huckleberry, Hughes Lake and Green Valley Circuits in Los Angeles County which were expected to meet PSPS criteria between July 14 and July 16. Operating restrictions remained in place for portions of Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, Santa Barbara and Tulare counties through July 16.

SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers. At approximately 7:00 p.m., SCE informed Clean Power Alliance, a community choice aggregator that it was within scope for the current PSPS event.

*Saturday, July 13*, based on updated forecasting analysis and improved conditions, the Hughes Lake, Underwood, Hession, and Birchim Circuits in Los Angeles and Inyo counties were removed from the PSPS monitoring list. SCE meteorologists added the Tejon Circuit in Kern and Los Angeles counties, the Showdown, Pelona and Anaverde-Ritter Ranch

Circuits in Los Angeles County and the Penstock Circuit in San Bernardino County, which were all expected to meet PSPS criteria between July 16 and July 17.

Operating restrictions were initiated for Ventura County and remained in place for Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, Santa Barbara and Tulare counties, through July 17. SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers.

*Saturday, July 14*, based on updated forecasting analysis and improved conditions, the Bonanza, Penstock and Anaverde-Ritter Ranch Circuits were removed from the circuit monitoring list. SCE meteorologists added the Birchim Circuit in Inyo and Mono counties, Hession and Underwood Circuits in Inyo County, Hughes Lake, Green Valley, Pronghorn, and Whip Circuits in Los Angeles County, Devers-Venwind, Blast-Bottle-Windfarm, and Sheraton in Riverside County, and the Campanula, Morongo, and Pioneertown Circuits in San Bernardino County which were expected to meet PSPS criteria between July 14 and July 16.

Updated forecasting analysis in the afternoon resulted in the removal of the Birchim, Hession, Underwood, Shovel, Devers-Venwind, Campanula, Hughes Lake, Morongo, Pioneertown, Player, Pronghorn, Sheraton, Showdown, and Blast-Bottle-Windfarm Circuits. The Cuddeback Circuit in Kern County, Acrobat Circuit in Los Angeles County, Cantina Circuit in Riverside County, and Cushenbury, Doble, Seaforth and Cottonwood-Permanente Circuits in San Bernardino were added to the monitoring list and expected to meet PSPS criteria between July 15 and July 18.

Operating restrictions remained in place for Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, Santa Barbara, Tulare, and Ventura counties through July 17. SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers.

*Monday, July 15*, PSPS IMT 3 reported to the EOC at 7:00 a.m. to assume command from PSPS IMT 2. Based on updated forecasting analysis, the Bonanza, Flycatcher, Devers-Venwind, Shovel, Blast-Bottle-Windfarm, Campanula, Hughes Lake, and Showdown Circuits were added to the circuit monitoring list and expected to meet PSPS criteria between July 16 and July 17. The Cottonwood-Permanente, Acrobat, Cantina, Cushenbury and Doble Circuits were removed from the circuit monitoring list based on improved conditions. Operating restrictions remained in place for Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, Santa Barbara, Tulare, and Ventura counties through July 17.

SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and approximately 28,000 potentially impacted customers. Based on updated forecasting analysis, the Bledsoe Circuit in Kern and Los Angeles counties, Mirage-Capwind-Devers-Tamarisk in Riverside and San Bernardino counties, and Morongo

Circuit in San Bernardino County were added to the circuit monitoring list and expected to meet PSPS criteria between July 15 and July 16. The Penstock, Sea Forth and Showdown Circuits were removed due to improved conditions.

*Tuesday, July 16*, based on updated forecasting analysis, SCE meteorologists added three circuits to the circuit monitoring list; Penstock in San Bernardino County, and Acrobat and Subida Circuits in Los Angeles County were expected to meet PSPS criteria through July 17. The Bledsoe, Cuddeback and Whip Circuits were removed from the circuit monitoring list due to improved conditions. Operating restrictions remained in place for Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, Santa Barbara, Tulare, and Ventura counties and were extended through July 20.

Later in the day, the Acrobat, Bonanza, Borel-Isabella, Campanula, Flycatcher, Huckleberry, Hughes Lake, Mirage-Camwind-Devers-Tamarisk, Penstock, Shovel, and Subida Circuits were removed from the circuit monitoring list based on improved conditions. SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers. At approximately 12:00 p.m., SCE informed Lancaster Choice Energy, a community choice aggregator that it was within scope for the current PSPS event.

*Wednesday, July 17*, based on updated forecasting analysis and improved conditions, SCE meteorologists removed the Bootlegger, Mustang, Canebrake, Horse Mountain, Faye, and Fingal Circuits from the circuit monitoring list. The Penstock Circuit was added to the circuit monitoring list during the morning update, and removed later the same day based on improved conditions. Updated forecasting analysis in the afternoon resulted in the addition of the Mustang and Bonanza Circuits in Kern County and removal of the Tejon Circuit.

Operating restrictions remained in place for Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, Santa Barbara, Tulare, and Ventura counties through July 20. SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers.

*Thursday, July 18*, based on updated forecasting analysis and improved conditions, SCE meteorologists removed the Mustang and Bonanza Circuits from the monitoring list. By the afternoon, the Erskine, Borel-Isabella and Tungsten Circuits were removed from the monitoring list due to improved conditions, and SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers. Operating restrictions remained in place for Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, Santa Barbara, Tulare, and Ventura counties and were extended through July 21.

SCE meteorologists added a total of five circuits in Mono County; the Hurley, Sitzmark, Slalom, Slope and Tufa Circuits, which were expected to meet PSPS criteria on July 22. SCE did not make any notifications on the newly added circuits in accordance with SCE's internal notification protocols.

*Friday, July 19*, based on updated forecasting analysis, the Erskine, Bootlegger, and Boreal-Isabella circuits, located in Kern and Los Angeles counties, were added back on the monitoring list and expected to meet PSPS criteria between July 21 and July 23, while the Hurley, Sitzmark, Slalom, Slope and Tufa Circuits in Mono County were removed from the list due to improved conditions. SCE meteorologists later removed the Bootlegger Circuit based on updated forecasting analysis and improved conditions. Operating restrictions were released for Mono, Ventura and Santa Barbara counties, and remained in place for Inyo, Kern, Los Angeles, Riverside, San Bernardino, and Tulare counties through July 23.

SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers. The decision was made to manage the incident remotely over the weekend and daily situational awareness calls were scheduled with the IMT through Sunday, July 21 to evaluate the updated circuit list and identify the need for the IMT to report back to the EOC.

*Saturday, July 20*, based on updated forecasting analysis, the Cantina and Carriage Circuits in Riverside County were added to the monitoring list and expected to meet PSPS criteria on July 24. SCE provided updated notifications to emergency and public safety partners, critical infrastructure providers and potentially impacted customers. SCE did not make any notifications on the newly added circuits in accordance with SCE's internal notification protocols. Operating restrictions were initiated in Mono County and remained in place for Inyo, Kern, Los Angeles, Riverside, San Bernardino, and Tulare counties through July 23.

*Sunday, July 21*, based on updated forecasting analysis, seven circuits were added to the circuit monitoring list: the Doble Circuit in San Bernardino County, Bootlegger Circuit in Los Angeles County, Birchim Circuit in Inyo and Mono counties, Hession Circuit in Inyo County, and the Grenade, Southridge and Trevino Circuits in Riverside County which were all expected to meet PSPS criteria between July 23 and July 24. The Carriage Circuit in Riverside County was removed from the circuit monitoring list based on improved conditions. Operating restrictions remained in place for Inyo, Kern, Los Angeles, Mono, Riverside, San Bernardino, and Tulare counties through July 26.

Updated forecasting analysis in the afternoon resulted in the removal of the Doble, Bootlegger, Cantina, Grenade, Hession, Southridge and Trevino Circuits. The Sinkers and Control-Oxbow Circuits in Inyo County and the Sagehen Circuit in Mono County were added to the monitoring list and expected to meet PSPS criteria between July 22 and July 25. SCE provided initial and updated notifications to emergency and public safety partners,

critical infrastructure providers and potentially impacted customers in accordance with internal notification protocols.

It was determined that PSPS IMT 3 would report to the EOC at 9:00 a.m. Monday, July 22, to transfer command to PSPS IMT 4. For reporting purposes, the decision was made to conclude the PSPS event that began on July 9 and begin a new PSPS event beginning July 22.

**Response to ESRB-8 Requirements**

The following material addresses Resolution ESRB-8 requirements in each of the categories associated with notifications. Each of these categories is addressed in separate sections.

**1. The local communities’ representatives contacted prior to de-energization, the date on which they were contacted, and whether the areas affected by the de-energization are classified as Zone 1, Tier 2, or Tier 3 as per the definition in General Order 95, Rule 21.2-D**

SCE maintained ongoing communications with potentially impacted jurisdictions (counties and cities) throughout the duration of the weather event ending July 21, 2019. Additionally, PDF maps and electronic mapping files for affected areas were made accessible to all impacted areas at [www.sce.com/maps](http://www.sce.com/maps). As chronicled above, SCE also routinely submitted the CalOES Public Safety Power Shutoff Notification Form to the State Warning Center as conditions changed.

The following table illustrates when initial contact was made as required, and a copy of all messaging is located in Appendix B of this report.

Advanced notification of this Public Safety Power Shutoff event was communicated to all impacted counties, CalOES and the CPUC approximately 72 hours before any forecasted weather was scheduled to impact the SCE service territory. Regular updates were given throughout the event using the CalOES PSPS Notification Form, daily situational awareness calls and individual contact with the impacted counties. Additional information regarding SCE’s engagement with public safety partners is provided above in the Event Timeline and Responses to ESRB-8 Requirements.

**5. Notifications continue to be challenging for these PSPS events, and the fluidity of the circuit monitoring list presents a unique set of circumstances that sheds light on the importance of a coordinated response effort. During this activation, SCE employed a pre-notification meeting with the parties responsible for delivering notifications to state executives, local governments, public safety partners, critical infrastructure facilities and potentially impacted customers to establish a cadence and ensure all were aligned with SCE's internal notification protocols. SCE will continue to utilize this brief meeting for future PSPS events.
