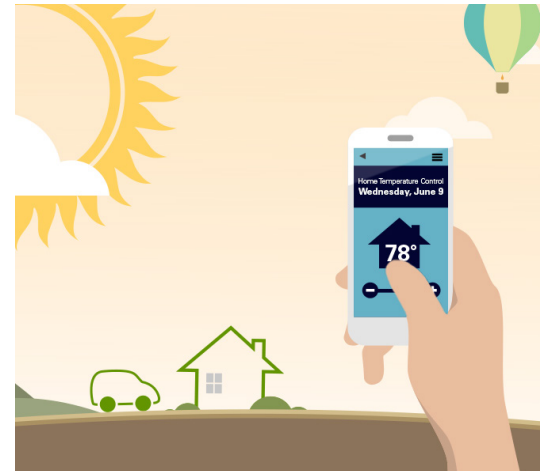


## Why Enroll Your Wi-Fi Smart Thermostat?

With up to \$125 in available bill credits, there has never been a better time to enroll your new or existing smart thermostat. If you are a joint customer of SCE and SoCalGas<sup>®</sup>, you'll get a \$125 SCE bill credit when you successfully enroll through a qualified service provider. If you are our customer, but not a customer of SoCalGas, you'll receive a \$75 SCE bill credit.

A Wi-Fi smart thermostat may help reduce your electricity usage and help you save on air conditioning (A/C) costs at home. Simply choose from a selection of qualified smart thermostats, then enroll in a qualified vendor's smart thermostat program that participates in our Save Power Days program. During Save Power Days events, your smart thermostat service provider may adjust the temperature and pre-cool your home – but you have the flexibility to adjust the temperature setting to help you stay comfortable. When you lower your A/C usage, you may be eligible for bill credits.



### Getting Started

- Own or purchase a qualified smart Wi-Fi connected thermostat.
- Enroll your smart thermostat through the qualified smart thermostat service provider's website. Note that the smart thermostat service providers may refer to our Save Power Days program using a different name on their website.
- Your smart thermostat service provider will notify you of your eligibility for the program.
- When a Save Power Days event is called, your smart thermostat service provider may automatically adjust the thermostat temperature in your home.
- Once you are enrolled, you do not have to re-enroll the following year.
- If you want to leave the program, please contact your smart thermostat service provider.

### How Does the Program Work?

- When a Save Power Days event is called, we will notify your smart thermostat service provider that an event will take place the following day (between 2 p.m. – 6 p.m.).
- Your smart thermostat service provider will notify you of the event, and may adjust your smart thermostat to pre-cool your home and/or change the temperature setting to reduce energy usage during the event.
- Additionally, your participation in a program can earn you up to \$60 in bill credits every year. You will earn \$1.25 in bill credits for every kilowatt-hour (kWh) saved during the event.

You can expect to see the bill credit on your next SCE statement.

- You always have the option to adjust your temperature setting at your discretion.
- Consider turning your temperature setting up a few more degrees, or turning your A/C off, for even greater savings.

### Did you know?

One kWh of electricity is enough to watch TV for 10 hours, vacuum for an hour, or work on a computer for 5-10 hours.

## How Are Credits Earned?

To calculate your earned bill credits, we compare your usage during the Save Power Days event to the three highest usage days for the previous five non-event, non-holiday week days during the same 2 p.m. to 6 p.m. time frame. If your usage is lower on the Save Power Day, you'll earn a bill credit of \$1.25 per each kWh reduced. You can save up to \$60 a year. Bill credits are based on participating in 12 four-hour events per year at \$1.25 per kWh saved.

## When Are Events Called?

Events can be called on non-holiday weekdays, typically from 2 p.m. to 6 p.m., throughout the year. Historically, events have been called during the summer. The decision to call an event is based on:

- Forecasts of extreme or unusual temperature conditions impacting system demand
- Anticipated statewide alerts and warnings for high-demand days
- System emergencies

## What's the Role of the Smart Thermostat Service Provider?

- Enrolls you in the program
- Notifies you of Save Power Days events
- Helps you reduce energy consumption by automatically adjusting the smart thermostat before and during event



## Eligibility Requirements

1. A qualified Wi-Fi A/C thermostat connected to a working central A/C
2. An internet connection
3. Residential "bundled" customer status, with an eligible Edison SmartConnect<sup>®</sup> Meter  
Customers who purchase their energy from an Energy Service Provider or Community Choice Aggregator are ineligible for this program.
4. You may not be enrolled in any of the following programs, rate plans or services:

5. Must be a customer of both SCE and SoCalGas to get a \$125 rebate. If you are our customer, but not a customer of SoCalGas, you'll receive a \$75 bill credit from SCE.
6. This is for new enrollments only. Residential customers who have a second home can qualify for up to two rebates.

Ongoing performance bill credits are solely funded by SCE, and initial incentives to join SCE's program are co-funded by SoCalGas under the auspices of the California Public Utilities Commission. The program will continue until funding is exhausted or the program is terminated, whichever comes first. Program is subject to change without notice. The \$125 sign-up bonus is for joint SCE and SoCalGas customers.

Bill credits are based on participating in 12 four-hour events per year at \$1.25 per kWh saved. See Program Terms and Conditions for details.
